- A. Terry Ostrander
 - 1. Multiple Propositions
 - a) Will there be multiple versions of the project proposed?
 - (1) Due to the requirements to pass specific propositions, it is not possible for multiple versions of the project to be proposed. The district is considering the possibility that certain items (or groups of items) might need their own proposition to give voters the opportunity to weigh in separately. To this point, nothing has been decided in that regard.

2. Cost Allocations

- a) Will details be given of the costs associated with the project?
 - (1) Yes. As the project begins to take shape, we will discuss and present publicly the estimated costs associated with different aspects of the project in a way that voters will be able to identify with.

3. Roof Work

- a) Will there be a thorough analysis of the roof to determine the scope of repairs needed?
 - (1) Yes. Some work has already been done to identify the areas of need. There are a variety of tests that will be performed to determine what scope of work is recommended for this project, including thermal imaging.

4. Hot Water Boilers

- a) Is it the plan of the district to convert all boilers from steam to hot water?

- 1. Hot Water System
 - a) Will the entire boiler system be converted to condensing hot water at some point?
 - (1) Yes, but it will likely not all be converted in this proposed project.

2. Collaboration

- a) Are you collaborating with the Galway Public Library and the fire department?
 - (1) We have met several times with the Galway Public Library with respect to planning and coordinating project timelines. Due to the fiscal relationship between the two, those discussions happen more frequently. It is our plan to collaborate with the fire department in the near future, as well. In fact, we have an extensive list of outreach efforts that we have planned over the coming months.

3. Security

- a) Has there been an assessment of the security needs of the district?
 - (1) Yes. Through various assessments, we have been able to identify and address many of the needs with respect to security of the building.
