Adopt the following resolution dated April 21, 2016 of the Board of Education of the Galway Central School District authorizing the transfer of funds to the Capital Reserve Fund:

WHEREAS, on March 24, 2016, the Board of Education of the Galway Central School District (the "School District") duly adopted a resolution authorizing a public hearing (the "Public Hearing") pursuant to Section 6-r of the General Municipal Law regarding the transfer of \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund; and

WHEREAS, notice of the Public Hearing was published in the School District's official newspaper at least five days before the date of the Public Hearing;

WHEREAS, the Board of Education held the Public Hearing on the date hereof; and

WHEREAS, the Board of Education desires to transfer \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund; and

WHEREAS, the Board of Education also desires to transfer \$513,601 from unappropriated/unrestricted fund balance to the Capital Reserve Fund;

NOW THEREFORE, BE IT RESOLVED BY THIS BOARD OF EDUCATION AS FOLLOWS:

Section 1. The School District is hereby authorized to transfer: (A) \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund; and (B) \$513,601 from unappropriated/unrestricted fund balance to the Capital Reserve Fund.

Section 2. This Resolution shall take effect immediately upon its adoption.

	PROPOSITION #2: Shall the Board of Education be authorized to: (1) renovate and reconstruct various School District buildings, undertake site work, reconstruct athletic fields, construct storage buildings, and acquire original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings are to be used, at a maximum cost of \$26,700,000; (2) expend \$1,750,000 from the Capital Reserve Fund to pay a portion of the costs of such purpose; (3) levy the necessary tax therefore, to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education taking into account state aid and the amounts expended from the Capital Reserve Fund; and (4) in anticipation of the collection of such tax, issue bonds and notes of the School District at one time or from time to time in the principal amount not to exceed \$24,950,000, and the levy of a tax to pay the interest on said obligations when due, be approved?
	<b>PROPOSITION</b> #3: Shall the Board of Education of the Galway Central School District be authorized to: (1) acquire a school bus and school vehicles at a maximum aggregate cost of not to exceed \$195,000; (2) expend such sum for such purpose; (3) levy the necessary tax therefore, to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education taking into account state aid; and (4) in anticipation of the collection of such tax, issue bonds and notes of the District and/or enter into installment purchase agreements at one time or from time to time in the principal amount not to exceed \$195,000, and levy a tax to pay the interest on said obligations when due?
