Stakeholder Proposal - Mr. Sutton

The Stakeholder Council proposal was discussed as an opportunity to increase financial efficiency and to maximize student achievement. There is a wealth of talent in the community; seek volunteers through the website and outreach within the community.

The initial meeting is to be held with the Superintendent and the Council. It should be a balanced committee. Start with sports and transportation. Then move into the areas of importance-i.e.: look at long-term (consolidation?), technology, and computer-aided instruction.

Propose soliciting volunteers for sports and transportation. Maybe more people interested to do this given the budget.

2009-10 School Report Card information - Mr. Clay

Mr. Clay began reviewing three main slides on the school report card information. The information was reviewed, explained and illustrated on a May 2011 school report card summary.

Comments:

- expand RTI/AIS into middle school and high school
- BOCES offers certificates for certain programs, can Galway do the same?
- Comparing our school to Saratoga County Districts around us, BOCES
- Why is our Regents number so low?
- What is it about Galway that is preventing greater achievement?
- Compare subjects, using item analysis.
- How can conversations help these students to achieve?
- Everyone needs to see the data.
- This summer teachers will begin curriculum work on the common core standards.

<u>Updated Technology Plan – Mr. Berry</u>

Mr. Berry presented information on the Galway Technology Committee – District Technology Plan Review: 2011-2014. New Plan contains a few changes. Two new objectives were noted. Need to use technology to increase gains in achievement. Technology matrix is being used currently in classroom. Use technology as a tool, not to replace education.

Budget Follow Up

Budget hearing – covered required elements and practical applications for Galway.

Summary - \$17,241,857 budget (-2.6% less)

Estimated tax levy increase - 4.6%

Two propositions – budget and purchase of 3 busses

Clarify few items:

- A. Admin. Component supervision—why an increase if we are reducing an administrative position? Three administrators reflected; two under the program component in the budget.
- B. Question on program, contract transportation and district transportation.

Last year 2010-11 bus lease payments were made in 2009-10; however, we will have lease payments due for 2011-12 (on current lease agreements). Contract transportation-out of district placements.

Several meetings are occurring in planning all changes:

Supervisor Teams

A question was asked examining current transportation and the feasibility of consolidating any runs. Two runs could be consolidated - savings on mileage (29,120) 2 drivers eliminated (\$52,000) fuel savings, (16,000) for a total of \$67,632.

Fiscal Plan:

Preliminary information is being developed – planning includes actual numbers from 2007-10, estimated 2011, projected 3 years out.

Board Goal Status Plan would be completed by August, 2011.

Mr. Sutton has requested an exact computation on fund balance.

Other
