# SUPERINTENDENT'S REPORT

Mrs. LaBelle gave an update on Race to the Top and reported that area schools are pooling their money together and looking at how best to spend Race to the Top funds.

The Budget Advisory Committee and the Task Force met and talked about their focus as a committee. They will meet again next month.

More time was needed on the Action Plans before they are presented to the Board. They will be K-12 in nature and used as a tool to see how Board goals are being addressed.

The District newsletter was recently mailed to the community. The focus is different than in the past with less pages, 2 colors instead of 4 and printed on non-glossy paper in order to save the district money. There is a section on the back of the newsletter requesting feedback from the community on how they like the new focus.
