# Galway Central School District Special Board of Education Meeting MINUTES Wednesday, May 23, 2012

#### **CALL TO ORDER**

The Board of Education Meeting was called to order at 8:02 AM in the Jr./Sr. High School Conference Room.

Board Members Present: Cheryl Smith, Dennis Schaperjahn, Joan Slagle, John Sutton,

(Thomas Rumsey was appointed later in the meeting)

Board Members Absent: Janet Glenn, Nancy Lisicki

#### **NEW BUSINESS**

Below are vacancies on the Board of Education that appeared on the ballot on Election Day, May 15, 2012. See below for election results.

- One vacancy is a four-year term of office that is effective July 1, 2012 June 30, 2016.
   This seat is currently held by Joan Slagle who is not seeking re-election.
- One vacancy is a four-year term of office that is effective July 1, 2012 June 30, 2016.
   This seat is currently held by John Sutton whose name appears on the ballot for re-election.
- One vacancy is a two-year term of office that is effective immediately following the election on May 15, 2012 June 30, 2014. This two-year vacancy is to complete Bradley Rooke's four-year term of office who resigned after serving one year on this term; Thomas Rumsey was then appointed for one year until the next general election on May 15, 2012 which results in a two-year vacancy. Mr. Rumsey announced that he was not seeking re-election.

All seats are "at large" which means that each nominee for a seat on the Board is eligible for every vacancy rather than only for a specific seat. The candidates with the most votes will get the four-year terms of office followed by the two-year term of office.

Motion: Dennis Schaperjahn Second: Joan Slagle All voted Aye. Motion Passed 4-0 Resolved that the Board of Education of the Galway Central School District accept the attached certified list of Board of Education election results. John Sutton was re-elected to another four year term of office on the Board of Education.

Motion: John Sutton Second: Dennis Schaperjahn All voted Aye. Motion Passed 4-0 Resolved that the Board of Education of the Galway Central School District accept the resignation of Joan Slagle as a member of the Board of Education with a term ending June 30, 2012 effective immediately. She will then be sworn in to a new term of office on the Board of Education for the balance of an unexpired term ending June 30, 2014 to which she was elected at the Annual Meeting of the District on May 15, 2012.

At this point Joan Slagle was administered an oath of office which was certified by the District Clerk for her new term of office on the Board of Education (until June 30, 2014).

Motion: Dennis Schaperjahn Second: John Sutton All voted Aye. Motion Passed 4-0 BE IT RESOLVED, by the Board of Education of Galway Central School District, Saratoga County, New York, as follows: Thomas Rumsey is appointed to fill a vacancy in the office of Member of the Board of Education of the Galway Central School District for the unexpired balance of the term of office of Joan Slagle, created by the resignation of Joan Slagle on May 23, 2012, until June 30, 2012. This resolution shall take effect immediately.

At this point Thomas Rumsey was administered an oath of office and the oath was certified by the District Clerk for his new term (until June 30, 2012). This is for Joan Slagle's unexpired term.
