It was stated that Amy Trigg is doing an outstanding job as Cafeteria Manager. The Board talked about some sort of recognition for her and for others in the future so employees know that they are appreciated.

Christine DeCristofaro, CSEA Union President, commented that the Substitute Custodian/Cleaner rate of \$11.11 per hour was increased to \$12.47 per hour and that the District just hired full-time Cleaners at a rate of \$11.11. She felt that substitutes should not make more than regular employees and that it is not fair to them. It was also noted that the Substitute Secretary rate of \$14.00 per hour (same rate as last year) is more than what one of our full-time secretaries is being paid. Mr. Shine will look into the matter further.

14. NEW BUSINESS

The Board wanted to make sure that no children are left behind if they cannot afford to go. Mr. Shine ensured that this is not the case at Galway and opportunities are available to all students and no child is left behind.

Approve a Junior Class trip to Salem, MA on Thursday, October 9, 2014 to see the play "Cry Innocent", visit the House of Seven Gables, take a harbor tour aboard the Schooner Fame and see other sites. Brown Coach will provide transportation and will leave the high school at 5 AM and return at approx. 9:30 PM. The cost is \$80 per student and parent chaperone.

Resolved that the Board of Education of the Galway Central School District award a bid to Noonan Leasing LLC, 227 Noonan Road, Fort Johnson, NY 12070 for the purchase of three (3) used 72-passenger school buses in the amount of \$32,500 each and one (1) used 22-passenger school bus in the amount of \$9,300 as per the attached. No other bids were received. Bids were publicly opened and read on July 9, 2014.
