CALL TO ORDER

The meeting was called to order by Melodye Eldeen, Board of Education President at 5:30 PM in the High School Conference Room.

EXECUTIVE SESSION

At this point in the meeting, the Board and those in attendance moved to Distance Learning Room #1 for a Distance Learning / Agriculture / Future Farmers of America (FFA) Presentation and then returned to the High School Library for the remainder of the meeting.

AWARDS/PRESENTATIONS

Distance Learning / Agriculture / Future Farmers of America (FFA)

A summary of the 2014-15 and 2015-16 FFA Leadership Conference was provided. A demonstration of Distance Learning capabilities and Google Classroom took place. Information was provided regarding Galway's involvement in the Schuylerville Agriculture program and Future Farmers of America.

Galway Robotics

Students gave a presentation on Galway Robotics and what it is all about. Robotics is a branch of engineering that involves the conception, design, manufacture, and operation of robots. This field overlaps with electronics, computer science, nanotechnology and bioengineering. It also promotes collaboration, critical thinking and STEM skills. One of our teams was selected to attend the Northern NYS VEX Robotics Competition in Syracuse. The students demonstrated the robot that was used in the competition. They talked about what was involved in constructing it and how they continuously tweak it to make it better. The students appeared enthusiastic and excited about the program. Some expressed an interest in pursuing a career in the field of robotics when they graduate from high school, as a result of their involvement in Robotics. The Board of Education thanked the students for a great presentation and congratulated them on their achievements. They proudly stated that this was an example of what Galway School is all about and the great opportunities provided to our students. The Board also thanked their advisor, Mr. Fana, for going above and beyond his duties, which included putting forth many long hours to benefit the kids. The students and were congratulated on a job well done and for an excellent presentation that everyone seemed to enjoy.

Budget Update

A Budget Update was provided by Tim Hilker, School Business Administrator which included revisions from the last board meeting. A PowerPoint presentation included the following: Budget Process Objectives, History of the Property Tax Levy, Property Tax Levy Limit, Property Tax Freeze Rebate, State Aid Proposal, Total Impact of the Gap Elimination Act (GEA), State Aide Proposal, Revenue Budget Summary, Elementary and Jr./Sr. High School Budgets, Special Education Budget, Student Support Services, Instructional Services, Professional Development Budget, Expenditure Budget, Open Items, Expenditure Budget, Bus Proposition, Capital Project information, and Important Dates. Mr. Hilker stated that it has been a positive year for the district finically and that the District is in good financial status. Priorities, open items, tax levy amounts, repair reserve amount and other options of the board were discussed. Mr. Rumsey indicated that he would like to end the year with approximately 6% in the fund balance reserve and expressed concerns with going lower than that. The budget will be presented at the next meeting where the Board has the option of finalizing the budget amounts.

AWARDS/PRESENTATIONS (Continued)

Child Nutrition/State Education Department Administrative Review

Mr. Hilker reported that the District received a positive review from the Child Nutrition/ State Education Department as a result of their Administrative Review of Galway School's food service operations. Mr. Hilker stated that a great deal of credit needs to be given to Amy Thompson, the District's Cook Manager, not only for the work she did in regard to the positive administrative review, but also for all she does on a daily basis. He stated that Mrs. Thompson has done a lot for the district and wanted to recognize her for her outstanding accomplishments. He stated that Mrs. Thompson is an asset to the District in many ways and wanted to make sure everyone was aware of all she does. The Board and administration expressed their thanks and appreciation to her for a job well done.

PUBLIC COMMENT ON AGENDA ITEMS

A question was asked regarding outdoor track repair costs being included in a capital project vs. being a part the school budget which was explained by Mr. Shine.

AGREEMENT

AGREEMENT made this 24th day of March, 2016 by and between the Board of Education of the Galway Central School District a municipal corporation having its principal place of business at 5317 Sacandaga Road, Galway, New York and Dr. Joseph L. Natale, residing at 60 Jean Place, Schenectady, NY 12303.

WHEREAS, the Board of Education of the Galway Central School District (hereinafter "the Board" or "the District"), desires to hire an Interim Business Official for the School District; and

WHEREAS, Dr. Joseph L. Natale (hereinafter "Dr. Natale") desires to serve as Interim Business Official for the District;

NOW THEREFORE, in consideration of the mutual covenants and promises herein contained, it is agreed as follows:

- The Board and Dr. Natale agree that, pursuant to a resolution of the Board, Dr. Natale shall be employed by the Board as Interim Business Official commencing March 17, 2016 and continuing on a per diem basis, to conclude upon the hiring of a permanent Business Official, but no later than August 1, 2016, unless extended by agreement between the parties.
- 2. Dr. Natale will be paid \$575 per day for his services. Half days will be paid on a pro-rated basis. Payment is for days worked only (e.g., there are no paid holidays).
- 3. The Board agrees to provide to the Interim Business Official the legal counsel and statutory indemnification/defense per Education Law and the Public Officers Law.
- 4. The Board will reimburse the Interim Business Official for the actual and necessary expenses incurred in the conduct of district business upon submission of appropriate claim information, including, but not limited to, mileage to attend conferences and meetings outside the district.
- The Board shall be responsible for withholding taxes and social security payments from payments made to Dr. Natale. He shall not be entitled to any other fringe benefits, including but not limited to any leave, insurance, pension or retirement contributions.
- Dr. Natale shall furnish and maintain throughout the length of this Agreement a valid appropriate certificate to serve as a Business Official in the State of New York.
- 7. Either party may terminate this agreement upon thirty (30) days written notice to the other.

WHEREAS, Section 6-r of the General Municipal Fund requires that any such transfer shall be made only by resolution of the Board of Education adopted after a public hearing held on at least fifteen days prior published notice in the official newspaper of the School District;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE GALWAY CENTRAL SCHOOL DISTRICT that the Board of Education shall hold a public hearing on April 21, 2016 at 6:30 p.m. with respect to the transfer of \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund and that notice of such public hearing shall be published in the School District's official newspaper at least fifteen days before the date specified for such public hearing; and BE IT FURTHER RESOLVED, that this resolution takes effect immediately upon its adoption.

Shall the Board of Education be authorized to: (1) renovate and reconstruct various School District buildings, undertake site work, reconstruct athletic fields, construct storage buildings, and acquire original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings are to be used, at a maximum cost of \$26,700,000; (2) expend \$1,750,000 from the Capital Reserve Fund to pay a portion of the costs of such purpose; (3) levy the necessary tax therefore, to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education taking into account state aid and the amounts expended from the Capital Reserve Fund; and (4) in anticipation of the collection of such tax, issue bonds and notes of the School District at one time or from time to time in the principal amount not to exceed \$24,950,000, and the levy of a tax to pay the interest on said obligations when due, be approved?

BE IT FURTHER RESOLVED, that the District Clerk is hereby authorized and directed to include notice of such proposition in the Notice of the Annual School District meeting.

BE IT FURTHER RESOLVED, that this resolution takes effect immediately.

NOTICE IS HEREBY FURTHER GIVEN that the Annual School Election of the qualified voters of the Galway Central School District will be held on Tuesday, May 17, 2016 between the hours of 10:00 AM – 8:00 PM prevailing time, in the Galway High School Gym, at which time polls will be opened to vote by electronic voting machine upon the following:

★ BUDGET

To adopt the annual budget of the Galway Central School District for the fiscal year 2016-2017 and to authorize the requisite portion thereof to be raised by taxation on the taxable property of said School District;

★ BOARD OF EDUCATION VACANCIES

To elect two members to the Board of Education to fill two vacancies. Each vacancy is a four-year term of office that begins on July 1, 2016 and ends on June 30, 2020.

Each petition shall be directed to the Clerk of the District; be signed by at least 25 qualified voters of the District; must state the residence of each signer, and must state the name and residence of the candidate. The petition shall describe the length of the term of office and contain the name of the last incumbent. All seats are "at large" which means that each nominee is eligible for every vacancy rather than only for a specific seat.

NOTICE IS HEREBY GIVEN that personal registration of voters is required. Anyone who wishes to vote must register if they are not a registered voter. Personal registration for district voters who have not voted in school or town elections during the past four years will be held on May 3, 2016 from 8 – 3:30 P.M. in the Office of the District Clerk located in the Galway Jr./Sr. High School. If a voter has heretofore registered pursuant to Section 2014 of the Education Law and has voted at an annual or special district meeting within the last four (4) calendar years, he/she is eligible to vote at this election; if a voter is registered and eligible to vote under Article 5 of the Election Law, he/she is also eligible to vote at this election. The Board of Registration will meet for the purpose of registering all qualified voters of the district pursuant to Section 2014 of the Education Law at the Galway Central School District, on May 3, 2016 between the hours of 8:00 A.M. and 3:30 P.M., and to add any additional names to the Register to be used at the aforesaid election, at which time any person will be entitled to have his or her name placed on such Register, provided that at such meeting of the Board of Registration he or she is known or proven to the satisfaction of said Board of Registration to be then or thereafter entitled to vote at such election for which the register is prepared. The register so prepared pursuant to Section 2014 of the Education Law will be filed in the Office of the Clerk of the School District at Galway School, and will be open for inspection by any qualified voter of the District beginning on May 3, 2016 between the hours of 8:00 AM - 4:00 PM, prevailing time, on weekdays, and each day prior to the day set for the election except on Saturdays, Sundays and holidays and at the polling place on the day of the vote.

FILING OF REFERENDA OR PROPOSITIONS

NOTICE IS HEREBY GIVEN, that pursuant to a rule adopted by the Board of Education in accordance with 2035 and 2008 of the Education law, any referenda or propositions to amend the budget, or otherwise to be submitted for voting at said election, must be filed with the Board of Education at the Administration Building of Galway School, located in the Board of Education Room of the Jr./Sr. High School no later than 30 days before the Annual Budget Vote at 4:00 P.M. prevailing time; must be typed or printed in the English language; must be directed to the Clerk of the School District; must be signed by at least 25 qualified voters of the District; and must state the name and residence of each signer. However, the School board will not entertain any petition to place before the power of the voters to determine, or any proposition which fails to include a specific appropriation where the expenditures of monies is required by the proposition.

Two Vacancies on the Board of Education – Nominating Petitions Available

Galway Central School has two vacancies on their Board of Education. Each are four year terms of office that begin on July 1, 2016 and end on June 30, 2020. These seats are currently held by Melodye Eldeen and Thomas Rumsey whose terms expire on June 30, 2016. At the end of a term, a Board member wishing to continue public service must be re-elected to another term. New York State Law does not limit the number of terms a member may serve.

The Galway Central School District Board of Education is composed of seven unsalaried citizens. Board of Education work sessions are generally held on the second Thursday of the month. Board meetings are usually on the fourth Thursday of each month. There are also special meetings called from time to time. The schedule of meetings is established prior to the beginning of each school year and is available on the District's website and calendar.

The Board of Education is an agency of the State of New York and is charged with governing the School District, not with day-to-day administration. Within the powers delegated by law, the Board is the policy-making, or legislative branch of the School District. The Superintendent of Schools is the executive officer charged with responsibility for administering the schools within Board policy.

The Board of Education is responsible for the general supervision of the schools. Although its members may not act individually, collectively they are responsible for all things done in the District. The Board exercises this responsibility by proper organization, delegation, and direction through policies adopted.

A meeting of the Board of Education must be conducted in a specified manner because laws and regulations require legal actions and the following of formal procedures. Meetings are for the transaction of the business of the school district. Board members, as elected officials, exercise their legislative authority. All formal actions of the Board must be conducted at a work session or meeting of the Board of Education. A vote of the majority of the Board is needed to pass resolutions.

Individuals seeking election to the Board of Education at the May 17, 2016 annual school election must submit a petition to the District Clerk, Linda Casatelli, with a minimum of 25 signatures from district residents. Completed petitions must be submitted to the District Clerk no later the 5:00 PM on Monday, April 18, 2016. To qualify for membership on a school board, an individual:

- Must be able to read and write
- Must be a qualified voter of the district, that is, a citizen of the United States, at least 18 years or older; and not a convicted felon or adjudged an incompetent; (Note: a convicted felon is barred from running for a seat on the Board of Education if his/her maximum prison sentence has not expired or if he/she has not been pardoned or discharged from parole).
- Must be and have been a resident of the district for at least one year, but need not be a taxpayer
- May not have been removed from any school district office within the preceding one year, or the preceding three years in the case of New York City community school board members removed for malfeasance or criminal conviction while serving as a member of a community school board
- May not reside with another member of the same school board as a member of the same family
- May not be a current employee of the school board
- May not simultaneously hold another incompatible public office
