## **PUBLIC HEARING**

A Public Hearing took place regarding the transfer of \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund. A public hearing is required in order to lower the reserve fund. By lowering the reserve fund the district will be able to lessen the tax impact of the capital project on taxpayers in the district. It was presented later in the meeting for board approval. Following the budget hearing, the Board continued with the board meeting agenda items.

#### AWARDS/PRESENTATIONS

Michelle McDougall and Brita Donovan introduced the Evans family and spoke about their recent journey entitled Ainsley's Angels - Power to Push. From July-September, 2015 Shaun, Nichole, Shamus and Simon Evans traveled from Seattle, Washington to the Bronx in New York City as a result of nine year old Shamus' vision. Shamus is a Galway School student who was born with cerebral palsy, which limits his primary means of mobility to a wheelchair He came up with the idea to run across the nation as a way to promote involvement for children with special needs. Shaun ran over 3200 miles and was pulled by Shamus for over 2000 of those miles in running chairs depending on road and weather conditions. Nichole and Simon acted as navigators and pit crew for the summer long mission. The Evans family traversed through 15 states as they made their way from coast to coast. They operated out of the Ainsley's Angels RV and towed a trailer loaded with Advance Mobility Freedom chairs to donate to families across America. During the course of the summer, they were able to donate nearly 30 chairs while promoting inclusion and made memories that will last a lifetime. The district is very proud of their accomplishments and wanted to give something back to the family. A large personalized sign was custom made in their honor which will displayed on school grounds near the outdoor track in their honor for everyone to see.

Everyone involved in this year's Odyssey of the Mind Competition were thanked for their hard work and congratulated on a job well done. Refreshments followed in the high school cafeteria.

National Junior Honor Society (NJHS) students gave a presentation NJHS. They provided information on what NJHS is all about and the many things they are involved in throughout the year. The board expressed thanks and appreciation to them for sharing their information and making them aware of the great things that they do which they may not have known about. They were asked to come back at some point for an update.

Mr. LaBarre, Athletic Director, provided an update on the District's Coach Hiring and Evaluation Process which was followed by a question and answer period. He was thanked for his hard work and dedication to the District.

## **BOARD MEMBER COMMENTS**

The Board thanked those that presented earlier in the meeting. Comments were made about the play that recently took place and the great job they did. They talked about the many good things happening at galway and upcoming activities such as the prom, field day etc. and thanked those involved for helping make those things happen.

Jay Anderson introduced Michelle Bombard who was in the audience. Her name appears on the May 17, 2016 election ballot as a candidate for a 4-year term of office on the Board of Education. He stated that the 2016-17 budget will be presented to the Board later in the meeting for approval. Mr. Anderson also stated that it has not been determined if William Brooks' Social Studies teacher position will be filled next year and that it is not included in the budget. (Mr. Brooks is retiring from his Social Studies teacher position at the end of the school year). He stated that although the position is not included in the budget, it does not mean that it can't be added if needed. Two teachers commented about the need for the position and asked that they not eliminate it.

WHEREAS, on March 24, 2016, the Board of Education of the Galway Central School District (the "School District") duly adopted a resolution authorizing a public hearing (the "Public Hearing") pursuant to Section 6-r of the General Municipal Law regarding the transfer of \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund; and

WHEREAS, notice of the Public Hearing was published in the School District's official newspaper at least five days before the date of the Public Hearing;

WHEREAS, the Board of Education held the Public Hearing on the date hereof; and

WHEREAS, the Board of Education desires to transfer \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund; and

WHEREAS, the Board of Education also desires to transfer \$513,601 from unappropriated/unrestricted fund balance to the Capital Reserve Fund;

NOW THEREFORE, BE IT RESOLVED BY THIS BOARD OF EDUCATION AS FOLLOWS:

Section 1. The School District is hereby authorized to transfer: (A) \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund; and (B) \$513,601 from unappropriated/unrestricted fund balance to the Capital Reserve Fund.

Section 2. This Resolution shall take effect immediately upon its adoption. All voted aye to approve the motion. Motion passed. 4-Yes 0-No

NOTICE IS HEREBY GIVEN that a <u>Public Hearing</u> of the qualified voters of the Galway Central School District, Galway, New York, will be held in the High School Library of said District on Thursday, April 21, 2016 at 6:30 PM prevailing time, with respect to the transfer of \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund as indicated in the following resolution approved by the Board of Education at the March 24, 2016 Board of Education Meeting:

WHEREAS, the Board of Education of the Galway Central School District (the "School District") desires to authorize the transfer of \$300,000 from the Retirement Contribution Reserve Fund to the Capital Reserve Fund: and

WHEREAS, Section 6-r of the General Municipal Fund requires that any such transfer shall be made only by resolution of the Board of Education adopted after a public hearing held on at least fifteen days prior published notice in the official newspaper of the School District;

NOTICE IS HEREBY GIVEN that petitions nominating candidates for the office of member of the Board of Education shall be filed with the Clerk of said School District, Linda Casatelli, at her office located in the Galway Jr./Sr. High School, 5317 Sacandaga Road, Galway, NY no later than 5:00 P.M. on Monday, April 18, 2016. Each petition shall be directed to the Clerk of the District; be signed by at least 25 qualified voters of the District; must state the residence of each signer, and must state the name and residence of the candidate. The petition shall describe the length of the term of office and contain the name of the last incumbent. All seats are "at large" which means that each nominee is eligible for every vacancy rather than only for a specific seat.

#### REGISTRATION OF VOTERS - MAY 3, 2016

NOTICE IS HEREBY GIVEN that personal registration of voters is required. Anyone who wishes to vote must register if they are not a registered voter. Personal registration for district voters who have not voted in school or town elections during the past four years will be held on May 3, 2016 from 8 – 3:30 P.M. in the Office of the District Clerk located in the Galway Jr./Sr. High School. If a voter has heretofore registered pursuant to Section 2014 of the Education Law and has voted at an annual or special district meeting within the last four (4) calendar years, he/she is eligible to vote at this election; if a voter is registered and eligible to vote under Article 5 of the Election Law, he/she is also eligible to vote at this election.
