Melissa O'Connor has the following certifications: Early Childhood Education Birth-2 and Students with Disabilities B-2. In order to be eligible for tenure, individuals receiving a probationary appointment as a classroom teacher must receive annual composite or overall APPR ratings of Highly Effective or Effective in at least three of the four preceding years. If the individual received a rating of Ineffective in the final year of the probationary period, (he or she) will not be eligible for tenure at that time. The regulations do not require that a teacher have Professional Certification at the time of tenure but the District may make it a requirement.

Approve the four year 1.0 probationary appointment of Lauren Darlington as an Elementary 4th Grade Teacher effective September 1, 2020 – August 31, 2024 in the tenure area of Elementary Education at Step 2 plus 39 graduate credits of the GTA Salary Schedule. Lauren Darlington has the following certifications: Childhood Education 1-6; Generalist in Middle Childhood Education 5-9 and Students with Disabilities 1-6.

In order to be eligible for tenure, individuals receiving a probationary appointment as a classroom teacher must receive annual composite or overall APPR ratings of Highly Effective or Effective in at least three of the four preceding years. If the individual received a rating of Ineffective in the final year of the probationary period, (he or she) will not be eligible for tenure at that time. The regulations do not require that a teacher have Professional Certification at the time of tenure but the District may make it a requirement.
