<u>PUBLIC COMMENT(S) ON THE AGENDA</u> – Eric Fajans commented that it is unprecedented that after less than a year of employment in the district that three administrators are going to be granted tenure. (See New Business for further information.)

An Elementary (K-6) School Summer School Proposal was presented by Michelle McDougall, Elementary School Principal. This self-funded summer school program would be held on July 8 - 31, 2013 on Mondays-Thursdays but students could attend any amount of the days. 10 kids per teacher, per day, are needed. Student enrollment determines the number of staff needed. If there is not enough staff from Galway we would advertise on OLAS. Students would be invited based on teacher recommendation. Teacher rate of pay is $30/hour \times 3 + 30/hour \times 3 + 30/hou$

An Elementary Building Team End of the Year Report was provided summarizing their activities this past year and initiatives for next year. SUPERINTENDENT'S REPORT

Mr. Scott reported that architects looked at the old bus garage and found it to be a substantial building with steel beams, etc. They are going to do an assessment on the building and check for asbestos, and report back to the district with their findings and a cost to repair the building with anticipation of using it as an added storage facility. He also talked about a recent newspaper article he read in the April 27th New York Times Newspaper that he found very concerning entitled *No Rich Child Left Behind* where research has shown that kids do better if they come from richer families. Mr. Scott found it to be very concerning and wanted to share this information.

The district is continuing part two of the search for a new Superintendent of Schools. The Board will meet with the WSWHE BOCES District Superintendent of Schools, Mr. James Dexter, next week and with potential candidates for the position. The same interview committees will be involved again.
